



Portfolio I

- 7.5% target long-term annualized rate of return
- Moderate Volatility
- Exposure to Private Equity, Venture Capital and Opportunistic Real Estate
- 20% target allocation to Fixed Income
- Portfolio II
 - 6.0% target long-term annualized rate of return
 - Lower Volatility
 - No exposure to Private Equity, Venture Capital and Opportunistic Real Estate
 - 50% target allocation to Fixed Income
